## **New Data Protection Regulations**

The new General Data Protection Regulations (GDPR) came into effect from the 25<sup>th of</sup> May 2018 and as such the GMG **must** produce a Data Protection Statement.

## **Data Protection Statement**

#### Introduction

Your personal data is data which by itself or with other personal data for the reasons set out below. We will collect most of this directly from this form. The sources of personal data collected indirectly are mentioned in this statement. The personal data we currently collect include:

- Full name and personal details including contact information (e.g. home address, email address, home and mobile telephone numbers).
- ➤ Personal data about other named contacts. You must have their authority to provide their personal details on this form. You should share this data protection statement with them beforehand together with details of what you are disclosing on their behalf.
- This statement also applies to anyone signing up to the GMG's Social Media Sites. Anybody signing up to these sites on behalf of your Club should also be shown a copy of this Statement.

### Providing your personal data

We will tell you if providing some personal data is optional, including if we ask for your consent to process it. In all other cases you must provide your personal data so we can process this Application Form.

## Using your personal data

We will process your personal data:

- As necessary to perform our agreement with you in order to update our records.
- As necessary for our own legitimate reasons, for good governance, accounting and managing of the GMG's business.
- As necessary to comply with any legal obligations.

### Sharing of your personal data

Subject to applicable data protection law we will not share your personal data with any other third party without seeking prior permission from you.

## Retention period for personal data

We will gather your personal data on an annual basis. The personal data from the previous annual period will be destroyed on the provision of new data.

### Your rights under applicable data protection law

Your rights are as follows:

- The right to be informed about our processing of your personal data.
- The right to have your personal data corrected if it is inaccurate.
- The right to object to processing of your personal data.
- The right to restrict processing of your data.
- The right to have your personal data erased.

#### Data anonymisation and aggregation

Your personal data may be converted into statistical or aggregated data which cannot be used to identify you, then used to produce statistical research and reports. This aggregated data may be shared and used in all ways described above.
